# **OFFICIAL RULES**

### I. SPONSOR

The G-Forclack Shotgun Giveaway (the "Sweepstakes" or "Promotion") is open to registered Target Sports USA AMMO+ Members ("AMMO+ Member(s)" or "Member(s)") and Mail-in Participants ("Mail-in Participant(s)") who are legal residents of the United States, excluding residents of Cal e AR-Type Semi-Auto 12 Gauge 5 Round 20" Barrel B ifornia, Connecticut, Delaware, District of Columbia, Florida, Hawaii, Illinois, Maryland, Massachusetts, New Jersey, New York, Washington, Alaska, and any other state or locality where AR-style semi-automatic 12-gauge shotguns are prohibited or have limitations to Sweepstakes.
